As part of its strategy and long-term plan to grow revenue by 40% outside of South Africa, PPC is expanding its operational footprint into the rest of Africa, including Algeria, DRC, Ethiopia, and Rwanda. PPC also produces aggregates, metallurgical-grade lime, burnt dolomite and limestone.

The PPC cement brands include the market-leading SureBuild brand, the first branded general purpose cement on the market, Botcem in Botswana, Unicem and PMC in Zimbabwe, Obras in Mozambique, SureRoad, road stabilisation cement and OPC, a special-purpose, rapid-hardening cement. PPC is passionate about investing in meaningful initiatives and projects that advance the industry's excellence and are committed to social upliftment and developing communities. PPC has implemented the Employee Housing Support initiative which will run over the next 3 to 4 years and see over 300 of its employees acquire a decent house.

The cement giant has actively invested in technology to reduce air emissions, minimise waste production, recycle and recover raw materials, enhance energy efficiency and conserve natural resources – while producing a reliable and affordable supply of building materials to support the economies of countries in which we operate.

PPC has progressed from a Level 7 Black Economic Empowerment (BEE) rating to a Level 2 rating last year, when it reached a 26% black ownership level within PPC South Africa. Over the last decade, the company saw a 67% increase in its female employee ratio and a four-fold increase of women in management roles. By the end of last year, female employees represented 21.7% of PPC's total workforce. PPC launched its Women's Forum in 2001, which represents a change in PPC around attracting, nurturing and advancing women's talent to effectively lead PPC.
