## IMESA BURSARY SCHEME

### BURSARY SCHEME A FOR NON IMESA MEMBERS

---

#### 1. OBJECTIVE OF THE BURSARY SCHEME A

The aim of the Institute of Municipal Engineering of Southern Africa's (IMESA) Bursary Scheme is: -

- (i) To offer financial assistance to students who would otherwise not be able to afford to study in the field of Civil Engineering or a related discipline of infrastructure engineering by contributing towards TUITION FEES.

#### 2. THE ALLOCATION OF BURSARIES

Bursaries will be granted at the discretion of the Executive Committee of IMESA to students who:

- (i) are studying for a Civil Engineering degree, or a qualification in a field that falls under infrastructure engineering
- (ii) are studying full time at any ECSA accredited tertiary educational institution in South Africa, and have successfully completed 1st year studies

#### 3. GENERAL INFORMATION

The following important conditions apply to the allocation of bursaries:

- (i) **For the 2023 study year, the maximum paid per bursary student is R50,000.** If the tuition fees are less than R50,000 for the year, the remaining amount can be allocated to prescribed books (book list to be supplied by the tertiary institution).
- (ii) The bursary amounts will be paid to the tertiary institution within 30 days of receipt of the student account statement, or as otherwise agreed upon between the student and the authorised representative of IMESA as delegated by the Executive Committee
- (iii) The first instalment shall only be paid once the student has furnished the following to IMESA Head Office:
  - ◆ An acceptable medical certificate.
  - ◆ Proof of enrolment for the specific course of study.
- (iv) Bursary applications must be received by IMESA before **15 September** the year proceeding the intended year of study
- (v) The prescribed application forms must be used, and can be obtained from the IMESA website: <https://www.imesa.org.za/bursaries/> or by e-mail from: [bursaries@imesa.org.za](mailto:bursaries@imesa.org.za)
- (vi) **Incomplete or late application forms, as well as application forms that are not accompanied by the required substantiating documentation, will not be considered, and will be disqualified.**
- (vii) IMESA will not be responsible for the employment of any student after the completion of his/her studies but will encourage the student to take up a career in Local Government if possible.
- (viii) All bursary applications must be accompanied by an affidavit declaring their parents' monthly income, as well as the student's financial situation.
- (ix) No bursary will be allocated retrospectively.
- (x) No bursary will be allocated for practical training.
